## **Who We Are**

At FCG, we address the specific needs of the healthcare system and its agents from a humanistic perspective. We use our uniquely innovative vision to tackle challenges in healthcare, taking advantage of an established network of public and private entities with whom we work in partnership. FGC functions as a matrix organization; our activity is comprised of projects developed in league with our collaborators. Our multi-disciplinary team consists of more than 130 professionals from numerous fields, notably those of medicine, psychology, sociology, economics, law and telecommunications. The singularity of FGC's approach is based in this rich network of partners and collaborators, our skill at management, and an unwavering commitment to our goals.

## **What We Do**

Our projects can be divided into three categories: programs related to the education and training of healthcare professionals, projects related to scientific dissemination of information and technologies related to healthcare, and applied research projects. As one might imagine, the nature of our involvement varies according to the type of project in question.

**Education and Training Projects:** We have years of experience in the coordination and execution of education and training programs, designing content and recruiting teaching staff and lecturers as well as providing logistical and technical support. In the past, such projects have included seminars, workshops. Our flagship program is a year-long Masters program in Healthcare Administration and Management, now in its 21<sup>st</sup> year. **Research Projects:** FGC participates in both qualitative and quantitative research projects in the field of healthcare. We perform analysis on data and micro-data gathered from diverse sources (among others, national health surveys) and, when necessary, use quantitative techniques to identify significant variables for the project in question and assist with bibliographical searches and analyses of other relevant information. FGC specializes in translating the findings of such projects to a more general audience, using mass media communication to publicize results and implications. **Scientific Dissemination Projects:** Our activity in this arena primarily involves conferences, meetings, debates, and public presentations of publications. FGC excels in an organizational capacity, planning events designed to foster communication both between healthcare professionals themselves and between the public and the healthcare community. Such projects are strongly tied to health advocacy. In recent years, we have explored ways to incorporate advances in information and communications technologies; most notably, we pioneered NETS, the first social communications network for the healthcare sector.
